ADOPTION AGREEMENT (v. 05/19)

WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

1. In consideration of being allowed to adopt _____
(Name/Breed/Age/ID Number) ("Canine"), I hereby RELEASE, WAIVE, DISCHARGE AND COVENANT TO HOLD HARMLESS Angels for Animals Rescue Organization, a California corporation, its officers, volunteers, employees, servants and/or agents (hereinafter referred to as "RELEASEES") from any and all liability, claims, demands, actions, including court costs and attorney fees, and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me as a result of the adoption / fostering of said Canine.
2. By adopting, I am: (a) now the sole legal owner of said Canine; (b) assuming complete responsibility of the Canine; and (c) agreeing to provide love, food, veterinary care and a secure environment for the Canine. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY/DEATH, that may be sustained by me or others as a result of adopting the Canine, WHETHER CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF RELEASEES. I understand that the Canine is capable of inflicting serious personal injury, including without limitation, dog bite injuries, and I voluntarily undertake such risk. I agree to safeguard others from the risks that Canine poses to them to the best of my ability.
3. I agree that I have made my own independent assessment regarding the temperament and behavior of said Canine and his/her suitability to be adopted by me. I have not relied upon any representation made by any of the RELEASEES as to the temperament of said Canine or his/her suitability as a pet. I AGREE TO SAFEGUARD ALL CHILDREN from said canine at all times.
4. It is my express intent that this Waiver of Liability and Hold Harmless Agreement shall bind the members of my family and spouse and my heirs, assigns and personal representative and shall be deemed as a RELEASE, WAIVER, DISCHARGE AND COVENANT TO HOLD HARMLESS the RELEASEES. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of California. Any proceeding or action shall be brought in State or Federal Court located in the County of Los Angeles.
5. IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed. No oral representations, statements, or inducements, apart from the foregoing written agreement, have been made. This Agreement supersedes all prior or contemporaneous agreements or understandings regarding the subject matter hereof.
6. I am at least eighteen (18) years of age and fully competent; and I execute this Waiver of Liability and Hold Harmless intending to be bound by same.
